■ **Microsoft** In 2016, two now former employees from Microsoft were implicated in corruption case involving bribes paid to Romanian officials to buy over market cost software licenses. The employees implicated are now separated from the company and Microsoft is cooperating with all aspects of the investigation and according to the chief prosecutor, is not a target of the ongoing legal probe.

■ **Johnson & Johnson** Multiple lawsuits have been filed against Johnson & Johnson alleging the company's talcum powder causes ovarian cancer, and that JNJ knew and did not tell the public. In February 2016, Johnson & Johnson was ordered to pay \$72 million to the family of an Alabama woman who died from ovarian cancer after using the powder. Further, in May 2016, a jury in Missouri ordered the company to pay \$55 million to a woman who claimed her ovarian cancer was caused by the powder. Johnson & Johnson would have been ranked No. 5 on the 100 Best Corporate Citizens List.

■ **Merck & Co. Inc.** In January 2016, Merck reached a \$830 million agreement to resolve a multi-district class action lawsuit in New Jersey federal court. Plaintiffs include those who purchased Merck securities from May 21, 1999, through Oct. 29, 2004, and sought to recover damages under the federal securities laws for Merck's statements on nonsteroidal anti-inflammatory drug Vioxx. Also, in July 2016, Merck settled a \$250 million equal-pay lawsuit, with more than 400 women claiming pay discrimination at the company. Merck & Co. Inc. would have been ranked No. 11 on the 100 Best Corporate Citizens List.

■ **Abbott Laboratories** In March 2016, Abbott Laboratories voluntarily announced a recall for a device used to implant clips into a heart valve, because a number of surgeons were unable to detach the device from the clip during surgery. The company plans to reeducate surgeons on the procedure, as nine devices malfunctioned, causing one death.

■ **Mosaic Co.** In August 2016, a large sinkhole opened underneath a gypsum stack at a Mosaic Co. phosphate fertilizer plant in Polk County, Florida. Mosaic Co. promptly notified the Florida Department of Environmental Protection (FDEP), the U.S. EPA, and Polk County and started the process to remove water from the affected process pond and repair the sinkhole.

■ **E.I. Du Pont De Nemours & Co.** In July 2016, The Department of Justice and the EPA announced a Clean Air Act Settlement that required E.I. du Pont de Nemours & Co. to reduce more than 13,000 tons of emissions annually from four sulfuric acid production plants in Louisiana, Virginia, Ohio, and Kentucky. In December 2016, the company agreed to pay a \$50 million settlement to resolve claims of mercury contamination from a former facility in Waynesboro, Virginia. E.I. Du Pont De Nemours & Co. would have been ranked No. 31 on the 100 Best Corporate Citizens List.

■ **Monsanto Co.** In May 2016, a court awarded \$17.5 million to three plaintiffs (including the family of a deceased plaintiff) who said their exposure to polychlorinated biphenyls (PCBs)—that Monsanto allegedly continued to sell after they were deemed dangerous—caused non-Hodgkin lymphoma. Monsanto would have been ranked No. 33 on the 100 Best Corporate Citizens List.

■ **Dow Chemical Co.** In February 2016, the Dow Chemical Company paid an \$835 million settlement agreement to resolve a lawsuit that alleged the company conspired with other companies to fix the price of urethane foam. The Dow Chemical Co. would have been ranked No. 47 on the 100 Best Corporate Citizens List.

■ **Bank of America Corp.** In June 2016, Bank of America Corp. discussed with U.S. regulators the possibility of paying up to \$450 million in a settlement, because of reports that BOA violated client account safeguarding rules. The Securities and Exchange Commission has been investigating the allegations.

■ **ConAgra Brands Inc.** In March 2016, ConAgra was found co-liable in a civil lawsuit stemming from alleged negligence from a 2009 North Carolina explosion caused by a gas leak during a water heater installation—resulting in multiple injuries and fatalities.
